

The Best Market

The OTCQX® Best Market offers transparent and efficient trading of established, investorfocused U.S. and global companies. To qualify for the OTCQX market, companies must meet high financial standards, follow best practice corporate governance, demonstrate compliance with U.S. securities laws, be current in their disclosure, and be sponsored by a professional thirdparty advisor. Penny stocks, shells and companies in bankruptcy cannot qualify for OTCQX.

The Venture Market

The OTCQB® Venture Market is for entrepreneurial and development stage U.S. and international companies. To be eligible, companies must be current in their reporting and undergo an annual verification and management certification process. Companies must meet \$0.01 bid test and may not be in bankruptcy.

The Pink Market

The Pink Open Market provides brokers with a regulated platform for transparent trading and best execution. Brokers quote a wide spectrum of companies on this market, including foreign companies that limit their disclosure in the U.S., penny stocks and shells. To be eligible for quotation on the Pink Market, companies must comply with the requirements of Securities Exchange Act Rule 15c2-11, including providing current information to the investing public.

Suncrest Bank Highlights

Going Public on OTCQX

Why Go Public on OTCQX

Bank Reporting:

 Companies can leverage OTC Markets' Bank Reporting Standards to complete their Reg D or registered offering to trade on OTCQX. NASDAQ and NYSE require full SEC registration pursuant of the '34 Act, which can be costly and burdensome

Liquidity:

 OTC Markets offers a diverse network of 90+ broker-dealers that transacted \$507 in annual dollar volume for 2022. Some of largest subscribers include Raymond James, DA Davidson, Janney Montgomery Scott, Piper Sandler, and KBW

Blue Sky Recognition:

• OTCQX is recognized by the SEC as an Established Public Market, providing a manual exemption in the majority of U.S. states for secondary trading

OTCQX Going Public Process

Amendments to SEC Rule 15c2-11, Effective as of Sept. 28, 2021:

 OTC Markets may onboard companies directly on the OTCQX Market. Through SEC recognition of our information review and disclosure standards, SEC Rule 15c2-11 streamlines the pathway for companies to raise capital and provide liquidity for their shareholders.

Following the Rule Change:

- OTCQX applicants that do not have a public market may become publicly traded and assigned a trading symbol by undergoing an "Initial Review" by OTC Markets Group.
- Broker-dealers may use our OTCQX Qualifications in lieu of submitting a Form 211 with FINRA




Understanding Blue Sky Compliance

What are Blue Sky Laws?

- State laws that regulate the solicitation, sale of securities and distribution of research to retail and non-accredited investors. Blue Sky laws were designed to help protect investors from fraud and help make informed decisions by mandating accurate and current information is available.
- Issuers actively seeking to increase ownership need to think about how to grow their Blue Sky Compliance
- Blue Sky status can change on a daily basis. Being on the OTCQX Market provides a blanket exemption which can be relied on year-round to facilitate trading
- OTC Markets Blue Sky Data is utilized by leading broker-dealers and compliance teams
